Founded in 2004, the DC Firefighters Burn Foundation is a non-profit organization established by active and retired Washington, DC firefighters. The Foundation is dedicated to assisting in the recovery and rehabilitation of injured firefighters and burn survivors from the Washington metropolitan region. Since 2004 we have provided over \$2 million in funding for burn research, treatment, and rehabilitation programs at MedStar Washington Hospital Center and Children's National Hospital. Through our partnership with these two institutions, we offer a variety of aftercare programs for burn survivors that include adaptive sports programming, local outdoor recreation events, image enhancement products/training, a summer burn camp for young burn survivors, and survivor support groups, all at no cost to the burn survivor. Firefighters and members of the burn team have a special empathy for burn survivors. No other group witnesses more of the devastation that fire wreaks on the human body and spirit.

On May 6, 2023, the DC Firefighters Burn Foundation will host the ***Night at the Wharf*** on the penthouse level of 1000 Maine Ave SW at the Wharf in Washington, DC.
